## 2017 In-House/FM Survey Results: CMM's Annual Analysis

*Key findings from the* 2017 In-House/Facility Management Benchmarking Survey

he Ohio State University (OSU) in Columbus, OH, is no small campus. It boasts approximately 600 buildings across 1,900 acres, and in 2015, had the third largest enrollment for public universities in the United States.

As the former director for environmental services for student life, Carl Bowman can tell you a lot about the university and its

facilities. When he worked there, he was in charge of the cleaning and maintenance for any building associated with student life with the exception of classrooms and labs. This included all the dormitories, dining facilities, recreation facilities, and even the student union.

Bowman says while working at OSU, one of the biggest challenges was making sure that all of his employees (225 at his high point) across campus were completing tasks to the same standard. "I wanted to make sure that the standard we had in one area was pretty much the same standard we had in another," he says. "Anything above and beyond would cost."

A good percentage of *Cleaning & Maintenance Management (CMM)* readers may be able to relate to Bowman's challenge from his time at the university. About 33.5 percent of survey respondents from *CMM's 2017 In-House/Facility Management Benchmarking Survey* work in education facilities at the college/university level, and about three-quarters of them are responsible for the cleaning/maintenance of 11 or more buildings. That's a lot of square footage and a lot of responsibility. Let's take a look at what else we learned from this year's survey respondents.

#### Survey Summary and Methodology

This year, 272 respondents completed the *In-House/Facility Management Benchmarking Survey*, with about 60 percent of them working in some type of education facility (33.5 percent

About 60 percent of this year's survey respondents work in some type of education facility. in higher education and 27.2 percent in K-12). The rest was split among hospitals (16.5 percent); commercial facilities, such as offices and government buildings (9.6 percent); long-term health care facilities (4.8 percent); hospitality facilities (4.0 percent); recreation/ transportation facilities

(2.6 percent); retail facilities (1.5 percent); and industrial facilities (less than .5 percent).

To conduct the 2017 *In-House/Facility Management Benchmarking Survey, CMM* editorial staff distributed the survey in April via email to all active contacts in the *CMM* in-house/facility manager email database. Survey questions were designed to address participants' operations, employee, and purchasing dimensions, along with additional critical issues in-house/facility managers face on a daily basis. #### Schools and Universities Rule

Education facilities employ nearly 61 percent of 2017 survey respondents. This group has been the largest percent of respondents for the past three years and is up about 13 percent from last year.

#### Services Stay In-House

Labor expenditures may be high, but FMs are trying to keep the work in house as much as possible. About **four out of five** FMs have not outsourced cleaning services in the past five years.

> Responsibilities Stretch Far and Wide

More than **one-third** of respondents manage at least 20 facilities and **43 percent** are responsible for at least 1 million square feet of space.

**Six out of 10** survey respondents said labor accounted for at least half of their operating budget.

#### Pest Control Takes Priority

FMs are most likely to outsource pest control services over other types of services. Restoration for fire and water damage follow closely behind, with roof maintenance and repair coming in third.



Budgets Are Steady

About **42 percent** of total respondents are looking at flat budgets for the 2017-18 fiscal year; however, particularly in higher education facilities, the same percentage of respondents are looking to cut expenses.

#### Wages Vary

More than **one-third** of respondents start their front-line employees with an hourly wage of **US\$10-12 per hour.** However, for the rest, starting wages land all across the board. 8 Facts About Your Fellow FMs




### **Online Purchasing**




## Q2 Which of the following best describes your job title/function?


#### Q3 Which of the following best describes your management responsibilities


## Q4 In what geographic region is the facility/are the facilities you manage?


## Q5 How many buildings/facilities are you responsible for cleaning/maintaining?


## Q6 How much square footage are you responsible for cleaning/maintaining?




# Q7 Which of the following best describes your facility(s) type?





### Q8 What level of LEED certification has your facility/facilities achieved?








Q10 Please select one statement that best describes your 2017-2018 operating budget.










#### Q12 What percentage of your operating budget is spent on LABOR?






Q13 Which of the following areas/surfaces are the most problematic in cleaning/maintaining your facility?










Q19 What portable technology do your employees utilize for their jobs? Check all that apply.






Q20 How many staff are you responsible for/ do you supervise (directly or indirectly)?






Q21 How many full-time employees work in your cleaning/maintenance department?






Q22 How many part-time employees work in your cleaning/maintenance department?






Q23 What is the STARTING hourly wage for FRONT-LINE employees in your facility(s)?






## Q24 What is the average tenure of your cleaning/maintenance staff?






## Q25 What is the AVERAGE hourly wage for FRONT-LINE employees in your facility(s)?










Q27 What type of training do you offer employees in your facility(s)? Check all that apply.






Q28 Who provides training for your cleaning/ maintenance staff? Check all that apply.




Q29 What percentage of your operating budget is spent on cleaning/maintenance equipment and supplies (purchase and maintenance)?






Q30 Which of the following describes your role in the purchasing of equipment and supplies?


#### Q31 Has your purchasing process changed in recent years?

Q32 To what extent do you purchase cleaning/ maintenance products from the following sources?








#### Q33 What percentage of your cleaning/ maintenance products are purchased ONLINE?
